TERMS AND CONDITIONS

WHAT IS INCLUDED: Hotels as indicated on the itinerary based on double occupancy; Meals; Admission to all sites as described in the itinerary; Transportation.

WHAT IS NOT INCLUDED: International air transportation; Travel/cancellation/emergency insurance; travel or accommodation expenses outside the designated tour dates; Incidental expenses; Anything else that is not specifically mentioned as included.

TOUR COSTS: Costs have been calculated on the basis of charges and exchange rates as of February 2018. Should these change, tour operator [Palomnik, LLC] reserves the right to make appropriate adjustments to the tour cost.

ALTERATIONS TO ITINERARY: Tour operator reserves the right to alter, modify or withdraw the itinerary if air schedules and/or events beyond his control deem it necessary. In the event it becomes necessary for the comfort or well-being of the travelers to alter or modify the itinerary or arrangements, such alterations may be made without penalty to the tour operator and are not grounds for cancellation with refund. Tour operator assumes no responsibility over any consequences as a result of any participant deviating from the group tour. Because of the difference in language and customs, it is expected that the traveler will follow the directions of the Tour Director at all times. Tour Director reserves the right to restrict a person's participation in the group's activities, including exclusion from the group, when, in the opinion of the Director, such action is necessary.

REQUIRED TRAVEL DOCUMENTS: A passport with validity for at least six months beyond end of stay, along with any visas required by host countries.

PAYMENT AND CANCELLATION POLICY:

Deposit payment of 15% is expected at the time of signing up for the trip
Second payment of 35% is due 120 days prior to departure, May 17, 2018
Balance payment of 50% is due 91 days prior to departure, June 17, 2018

Cancellation:

Full refund, 91 days prior to the departure (before June 17, 2018)
50% of the tour cost, 90 to 60 days prior to the departure (June 17-July 17, 2018)
100% of the tour cost 60 or fewer days prior to the departure (pass July 17, 2018)

All cancellations must be in writing and sent directly to Tour Operator – Palomnik, LLC and must be received for reimbursement by the dates shown in the cancellation schedule. We also have to add that should cancellation or alteration of the program occur due to civil disturbances, acts of terrorism, war, natural disaster, and other events of force majeure or acts of God (including threat or fear of same), refunds will be made only to the extent that they are recoverable, and that such cancellation or alteration may result in the total loss of funds paid by participants. It is assumed each participant has reviewed the same with respect to their own comfort level of risk and personal safety. A decision to withdraw from the trip for these reasons or any others will be bound by the same terms of cancellation.

RESPONSIBILITY: Tour Operator, does not hold any legal responsibilities concerning any of the arrangements, but acts solely as a coordinator. He will not be responsible or liable for any injury, loss, accident, delay or irregularity which may be occasioned by of any defect or through neglect or default of any company or person engaged in conveying or accommodating the travelers; nor for any delays, injuries, damages or losses resulting directly or indirectly from any acts of God, acts of governments, de jure or de facto, wars whether declared or not, hostilities, civil disturbances, terrorist activities, riots, thefts, pilferage, epidemics, quarantines, medical or customs regulations, or from any causes beyond the control of Tour Operator.
